## 332. NEIGHBOURHOOD PLAN PROCESS UPDATE

Anthony Rae outlined that there had been some delay in the Neighbourhood Planning process whist we undertake due process. The SEA is now in stage two of six. In respect of the Local Plan, this is due to open for consultation in January, with a view to the process concluding in May, as such it may be that the Neighbourhood Planning process re-joins the local plan in the spring and that the two plans align. It is unlikely that the Local Plan will publish any further allocated housing or employment sites.

There is also the matter of the Mytholmroyd Masterplan and subsequent public realm proposals. The requirements to have sight of the Community Association Feasibility Study conducted by CMBC and to have a meeting with the Community Association was highlighted. There is a requirement for a short chapter to outline the major elements for both Mytholmroyd and Hebden Bridge.

There is also ongoing uncertainly regarding the planning permission on the Browns site. And unanswered questions about the increased traffic from the proposed station car park.

To check with Aecom the extent of contact with Setbray and to arrange a meeting with Setbray. To ask Anne Holdsworth for any feedback on the public realm proposals and for the feasibility study.

#### 469. NEIGHBOURHOOD PLAN PROCESS UPDATE & SEA

The SEA Scoping report has been sent back to Aecom and is now with the statutory consultees who have until early March to comment. There has been no feedback yet. Aecom has requested further information on sites both allocated within the plan and those that have been filtered out. It is imperative to contact Setbray as landowner of a site in the Mytholmroyd Masterplan. Due to its re-allocation as Flood Zone 3b, Browns site has been removed from the list of key sites. Following an interesting meeting with Deakin Ass. in early 2019, there has been no further communication regarding the potential Market Place Scheme.

**RESOLVED:** To arrange a call with Aecom to discuss the requirements to enable to process to proceed, and to make contact with the various landowners associated with the key sites.

# 470. FEEDBACK ON MEETING WITH MYTHOLMROYD COMMUNITY ASSOCIATION

Anthony Rae and Emma Green recently attended a meeting with the Trustees of Mytholmroyd Community Association, as the landowners of one of the key sites within the Mytholmroyd Masterplan. The purpose of the meeting was to establish the future ambitions for the Community Centre and how the Neighbourhood Plan could help to facilitate these by providing an appropriate planning framework which will allow expansion. Various options were discussed, and it is clear that the use of the site remains that of a community hub, although the careful use of the waterfront could provide opportunities. It was established that there is indeed a right of way through from Streamside Fold despite notifications stating otherwise.

**RESOLVED:** that Cllr Slater will continue to liaise with the Trustees and that a separate meeting will be arranged with John Chilvers, the centre manager and Cllr Slater, Trustee, to further discuss ambitions for the site and consider how they can be incorporated in to the plan.

### 471. IMPACTS OF FLOODING & CLIMATE EMERGENCY

The impact of flooding and the need for resilient design was discussed as currently the only allocated site within the plan that does not flood is Walkley's. Cllr Kimber questioned the possibility of the Government issuing a ban on building on floodplains. It was discussed that the avoidance of sterilisation is the purpose of these sites and that exception tests would be implemented The Friends of the Earth 20 point checklist was discussed and the requirement of the use of SUDS to be incorporated in to the plan along with any other amendments relating to climate emergency,

**RESOLVED:** That the Neighbourhood Plan be amended where required to fully incorporate appropriate flood or climate emergency factors.
