160. BUDGET UPDATE & BUDGET REQUEST 2020/21

Councillors received an update of the current year's budget. The budget for 2021/22 was discussed.

RESOLVED: to request that a sum of £30,000 (£27,000 for environmental projects and £3000 for Allotments) is considered by the Strategy & Review Committee, the Neighbourhood Manager will complete and submit the budget request form with a breakdown of the proposed budget.

161. ALLOTMENTS UPDATE

There is currently one vacant plot and six applicants on the waiting list. Plot inspections are currently suspended, as is the introduction of new tenants during the current restrictions. The installation of the water has been well received. There has been a request for tree works at Banksfield allotments, the Neighbourhood Manager will follow this up.

The committee was updated of the intention to work with the Hebden Royd Wildflower Collective, a meeting is to be held on Monday 12th October, following which, a proposal and costings will be presented to members of this committee prior to the next meeting, to enable to project to be progressed.

319. MATTERS ARISING FROM MINUTES OF THE MEETING HELD 7th OCTOBER 2020.

Cllr Young asked about Wildflower Planting. It was confirmed that a meeting had taken place with the Hebden Bridge Wildflower Collective who were interested in supporting the Town Council to deliver a range of sites.

320. BUDGET UPDATE & BUDGET REQUEST

It was moved by Cllr Young Seconded by Cllr Harvey and

RESOLVED: to note the information.

321. ALLOTMENTS UPDATE

The committee were given a verbal report on the use of the allotments and the fact that many people had not been able to access their plots this year due to reasons related to Covid19 (either ill health or shielding) as such there would be no termination of tenancy but all plot holders have been contacted to confirm if they do still wish to keep their plots. At High Hirst there are currently two vacant plots and four people on the waiting list. At Banksfield there are no vacant plots and six people on the waiting list. The water supply at High Hirst had been well received and was being used sensibly by plot holders. The water is currently turned off at the mains for the winter. It was moved by Cllr Young

Seconded by Cllr Harvey and

RESOLVED: that due to the uncertain year and the requirement to use the water supply for the planting at the High Hirst Wood Meadow, the committee would fund the water bill this year, expected to be £400-£500, however from April 1st, the water bill will be shared between plot holders signed up to the water scheme.

322. FIELDING STREET LANDSCAPING

The proposal for planting and barriers at Fielding Street was considered. It was moved by Cllr Young

Seconded by Cllr Hoyle and

RESOLVED: that the scheme be approved and a budget allocated of £1210.00, providing that permission is granted. The landowner will be encouraged to contribute, and it will be made clear that the Town Council does not take responsibility for ongoing maintenance.

323. PROJECT UPDATE

New projects were discussed;

Replacement of broken planters, general maintenance, and care of apple trees at the Little Park.

A campaign to reduce litter which has notably increased during this period as more people use the countryside and footways.

RESOLVED: for the officer to consider ideas and collate costings for the above projects, to be considered at the next meeting.
